	d.	The AGENCY'S independent investigators will conduct a nationwide bank asset investigation which is inclusive of the following: nationwide bank accounts, safety deposit boxes, certificates of deposits, brokerage accounts, nationwide real property, credit profile, motor vehicles, liens & judgments for a fee of \$900.00.					
	e.	The contingency fee schedule includes all necessary attorney fees to effectuate a garnishment. Once garnishable assets are identified, the client will be responsible for a fee of \$400.00 for the cost associated with the garnishment.					
	f.	If your judgment debtor has moved from the state that issued your judgment, said judgment must be domesticated to the state in which the debtor currently resides before any garnishment activities can commence. In such case, Client must provide AGENCY with an exemplified copy of the judgment and pay an out-of-pocket cost of \$1,100.00.					
	g.	If litigation is necessary in remedying any breach of this Retention Agreement, all costs and expenses of litigation, including attorney fees, incurred by AGENCY will be borne by the non-prevailing party. Each agrees and acknowledges that the laws of Florida shall govern the validity construction, interpretation, and effect of this Agreement.
